VENDOR DESCRIPTIONS

Corporate Merchant: A merchant is an entity who trades in commodities that they did not produce themselves. I.E. Tupperware, Avon, Statefarm Insurance, Herbalife.

Non Profit: Charitable organizations that are building awareness for their cause. Proof of 501c3 required with application.

Food Vendor: Restaurants, grocery stores and institutional food providers selling food. Please note food vendors are not allowed to sell any type of liquids, drinks, or beverages.

Sponsor: A sponsor is a recognized person or organization that will support our event by providing financial assistance, products or services...To be a sponsor please call 815-209-3017 for more information. DO NOT fill out an application.

VENDOR INFORMATION

HOURS OF OPERATION

Saturday, September 14th 2019 Hours are 12:00pm -10:00pm Vendors must stay at least until 7:00pm

SET UP // CHECK IN

You may start setup as early as 8:00am on Saturday morning. All food vendors must be setup by 11:00 AM for inspection by WCHD.

BOOTH SPACES

All vendors must supply their own 10 x 10 pop up canopy. The canopy should be straight leg and 4 sided.

All vendors must stay up at least until 7:00pm unless otherwise noted and be removed by 11:00 PM.

All vendors must have a professional appearance, keep in mind this is a family friendly event. Vendors cannot assign, sublease or separate part of their assigned space without permission of the Tamale Fest staff.

CLEANING DEPOSIT

If we feel that your products may put our event at risk you may be required to provide a \$100 cleaning deposit.

At the close of the Festival, food vendors must leave their space clean or face a fine. The Festival will provide a trash dumpster at your disposal.

VENDORS MERCHANDISE

No weapons are allowed to be sold at the event. We have the right to remove products that are not acceptable by city code, by law, or if we deem them inappropriate.

ELECTRICITY

Electricity is not available at this event. Please arrange your electricity needs accordingly with your own generator.

BEVERAGES // FOOD

No drinks of any kind may be sold or given away by any vendor. No outside food or drinks are allowed at all.

VEHICLES

For safety reasons, please offload all your supplies, products, and equipment by 10:00am. All vehicles need to be removed out of the Main festival area, by 11:00am.

SECURITY

The festival provides security during Festival hours. However, the Festival is not responsible for the inside contents of the vendor's area. Please secure all items and never leave your area unattended.

TAMALE CONTEST RULES

HOME FOOD PREPARATION

Home preparation is NOT allowed per Winnebago County Environmental Health (WCHD)codes. Please don't let this discourage you, if you have questions about this please contact us.

COMPLIANCE WITH THE LAW

Food vendors must comply with all health laws, ordinances, and regulations of the State of Illinois, City of Rockford, and Winnebago County Environmental Health Department.

ELIGIBILITY RESTRICTIONS

All individuals are welcome to participate in the festival, including culinary students. restaurants, and caterers as long as they adhere to all applicable state and local laws.

However only vendors that operate within a 30-mile radius would be considered for the contest.

TAMALE CONTEST RULES

All Tamale vendors may enter two different types of tamales in the contest. All Tamale vendors must provide two dozen tamales for judging. One of each kind you enter.

All Tamale vendors will be notified as to when to deliver your tamales. Any contestant who does not have their fully-cooked, hot tamales at this time will be disqualified.

All Tamale vendors must deliver their tamales without any logo or branding. This is a blind taste test.

JUDGING

A panel of (6-8) judges will taste the tamales and qualify contestants. Judges will determine the winner by assessing taste, technique, appearance and overall quality of the tamale. Ten (10) points will be assigned to each of the criteria for a maximum possible score of 40 points per judge.

Three (3) finalists will be awarded 1st, 2nd, and 3rd place based on a point system.

Contestants must be present at the tamale judging to win.

WINNER SELECTION & NOTIFICATION

Winners will receive two plaques one for the restaurant and one at a later date for the cook. Winners will be announced at 4:00pm on the day of the event. Winners are strongly encouraged to be present at the time of the announcement, however, if they are not present, the winners will be notified via telephone. An alternate winner will not be selected.

INSURANCE COVERAGE

The Festival requires no less than \$1,000,000 in general liability insurance coverage. Food vendors must submit a certificate of insurance as proof of insurance.

CANCELLATIONS

There are no refunds for any cancellations. The only exception is if the event is canceled due to an act of God.
